## Protesting Fracking Waste in Santa Fe on May 13th

Can you show up in Santa Fe in solidarity with **New Energy Economy** and **YUCCA** to tell our state government that we **don't want oil and gas fracking waste discharged** into our environment? The New Mexico commission in charge of protecting our water (the WQCC) is meeting on May 13 in Santa Fe at 9 for the final vote on rules which would allow these discharges.

We are asking all concerned New Mexicans to come prepared with a handheld sign using the back of the attached information sheet to show our unified demand to the Commission (Please forward this to your activist friends):

Republicans will aim to continue pushing forward on gutting Medicaid and SNAP to pay for tax cuts for billionaires and fund a detention camp archipelago. They have a host of fascists and oligarch minions awaiting confirmation. There's much more of Project 2025 to implement. And all the while, Trump and Musk are continuing to take a sledgehammer to equality under the law, dismantle our government to steal the "savings" and set up a new spoils system.

There will be a lot of fights we cannot win against them, but as MAGA speeds our nation down a dark path it is crucial that we use every tool available to slow them down. And it will be difficult to make it clear to the American public how serious the emergency is without our elected officials acting as though it is an emergency.

- In Congress, that means using procedural hardball.
- In the Senate, <u>blanket opposition</u>, <u>quorum calls</u>, <u>objecting to unanimous consent</u>, <u>demanding recorded votes</u>, <u>refusing to waive rules</u>, <u>fighting adjournments</u>, and <u>holds on nominees</u>.
- In the House, <u>calling for recorded votes</u>, <u>motions to recommit</u>, <u>motions to adjourn</u>, <u>privileged resolutions to bring up tough votes</u>, <u>offering endless amendments in committee</u>, or <u>whatever time-consuming measures the rules allow</u>. As House staffers put it in a strategy memo, "Republicans in Congress are surrendering their Constitutional responsibility to check presidential abuses. It is anything but business as usual."

Although we are starting to get Democratic members of Congress get more aggressive, with <u>votes forced on the anti-Canada tariffs</u> and <u>an increasingly large number of nominees being held</u>, there is much more they need to be doing to meet the moment. Let's contact them and ask them to do so now – and if not now, ask them what line Trump and MAGA would have to cross for them to start.
